CCTV – Bloomsbury Play Area Proposal – as requested by Cllr Philpot

1	PROJECT PROPOSAL
1.1	To consider the introduction of temporary CCTV cameras to cover hot spot areas such as Bloomsbury Play Area.
2	INTRODUCTION
2.1	Cllr Philpot has raised concerns about the persistent levels of anti social behaviour in Bloomsbury Park and requested consideration of CCTV in this area. In July 2020, this Committee considered CCTV in play areas and resolved that a) The Parish Manager investigates options for stand alone/mobile
	CCTV cameras
	 b) Anti social behaviour issues are monitored and reviewed by the Committee at a future meeting
2.2	Over the last 12 months there has been a change in the regular use of public parks and open spaces associated with Covid restrictions and lockdowns. Generally there has been no evidence of increased levels of anti social behaviour in West Swindon parks.
2.3	At Bloomsbury Park, there is anecdotal reporting of persistent smoking and littering. Reports are consistent with previous years. Volunteers have reported finding knives in this area. There has been a number of incidents of deliberate vandalism in most play areas in Swindon. In the last 12 months there was one incident in Bloomsbury Park.
3	PROPOSAL
3.1	The Parish Council would need to establish a case for installation of CCTV monitoring the public domain. To avoid issues relating to licensing/data control and retrieval, the simplest approach to CCTV is to secure an additional camera for installation to the Swindon Borough Council network (location would depend on installation requirements). This would be the most cost effective and practical option but would require Swindon Borough Council's agreement.
4	ІМРАСТ
4.1	Any use of CCTV must be proportionate and justifiably necessary .
4.2	The Parish Council has no enforcement powers so if this was the purpose of the CCTV, it would need to have support from the 'enforcing' organization that it would view and respond to incidents captured on CCTV.
4.3	It is unlikely that CCTV at Bloomsbury Park would deter the general gathering of young people in the youth shelter and kickabout space.

	Incidents captured on CCTV would be unlikely to then lead to cost
	recovery of damage for the Parish Council however it may improve the
	general fear of crime locally.
5	COSTS
5.1	The camera would be part of the CCTV monitoring across the Borough.
	Costs would be in the region of £1600 for a single camera. Monitoring in
	the region of £400 per annum for a single camera.
	There would also be signage costs.
	Costs in year one estimated: £2,200
	Costs in subsequent years £400 depending on contingency for
	repair/replacement.
6.	BUDGET
6.1	The Parish Council has not factored CCTV and maintenance for public
	open spaces into its annual budget.
7	FINANCIAL & OTHER IMPLICATIONS
7.1	Consideration would need to be given as to whether this is an effective
	response to deter vandalism and anti social behaviour and whether it is
	justified and proportionate.
7.2	Replacement or repair costs would need to be met by the Parish Council. It
	is not known what this could be.
8.	RECOMMENDATIONS
8.1	That this Committee notes the information in this report in order to discuss
	the advantages and disadvantages of CCTV.
8.2	That this Committee makes a resolution determining next steps for this
