# 33. Peatmoor Community Woodland

The Parish Manager presented the Peatmoor Community Woodland report, a copy of which appears as **Appendix A** in the Minute Book.

Roger Ogle from Peatmoor Community Woodland explained that although it was originally requested that West Swindon Parish Council consider taking on the tree management of the area, there are now reports of Ash die back locally, although none in Peatmoor Woodland as yet. As a representative of the group, Roger Ogle indicated that it would be prudent to leave the copse in the ownership of Swindon Borough Council. Mr Ogle asked if the Parish Council could assist with independent insurance for the group of volunteers.
