### 81. Apologies & Applications for Dispensation

## 82. Hedge & Shrub Cutting Update

Councillors received a report, a copy of which appears as **Appendix A** in the Minute Book. The Clerk updated the Committee on the commencement of winter hedge and shrub cutting. This will follow the same cycle as previous years. It was noted that replacement shrub planting would be undertaken in key locations. It was requested that consideration be given to improving the entrance to The Holbeins.

The Clerk advised that bulb planting was planned for the main roads across West Swindon with the addition of large scale '50' signs to note the forthcoming 50<sup>th</sup> anniversary of residents in West Swindon. The Clerk was advised that Westlea Park may need a review of bulb planting after an early mow over this year.

### 83. Road Sweeping and weed control

The Clerk gave a verbal report regarding the completion of the weed spraying and road sweeping. Councillors noted the improvements.

## 84. **Graffiti Policy review**

The Councillors received a report on the Graffiti Policy Review **Appendix B** in the Minute Book. It was requested that more publicity be given to the use of the jet washer.

**RESOLVED that** the Outdoor team prioritise Graffiti removal as part of day to day duties outside of core work being completed.

### 85. Play Update - Shaw Ridge

Councillors received a verbal update from the Clerk. Due to manufacturing issues, the new play area site at Shaw Ridge Linear Park will not be commenced until mid November.

### 86. **Deployment of Temporary Cameras**
